- the promotion of a precautionary attitude from workers at all levels, leading to the discontinuation of business in case of doubt about the possibility of unforeseen environmental damage;
- the commitment to control and reduce the consumption of energy sources and natural resources and in any case to implement a rational use of any product or material necessary for our business;
- the commitment to the correct use of chemical agents as well as the reduction of the environmental impacts deriving from the use of chemicals;
- the commitment and attention to fire and explosion prevention measures in manufacturing environments;
- the commitment to the control of emissions into the atmosphere deriving from manufacturing or support activities;
- the commitment to the reduction and correct management of waste produced in all our businesses;
- the commitment to the control of rainwater from manufacturing environments.
